SUBJECT: Informal Bid Request #2016-007 – Vegetative Debris Reduction and Removal

BACKGROUND: On November 28, 2016, the City of Goldsboro re-advertised for a unit price contractor to assist with the reduction and removal of the vegetative debris that is located at the temporary dump site. Due to a misinterpretation by the bidders of the measurement related to payment by the cubic yard after it had been ground, the bid had to be re-advertised.

DISCUSSION: On December 8, 2016, the bids were opened with 8 responsive bidders for the vegetative debris reduction and removal. The bids were reviewed by the Public Works Department, checked for accuracy and dependability and found to be in order. American Property Experts was the low bid of \$4.66 per cubic yard.

A bid tabulation is attached for information.

RECOMMENDATION: It is recommended that Council, by motion accept the low bid of \$4.66 cubic yard from American Property Experts and adopt the attached resolution authorizing the City Manager and City Clerk to sign the contract.
